#### Treasurer:

 Current account balances are as follows: The Main general checking account has \$17,729.44, Health \$3,471.31, and Rescue has \$6,504.48. The total of all CVVC accounts are \$27,705.23.

## Recording Secretary:

 A motion was made to accept the minutes as written from the March 10, 2014 General Membership meeting. The motion was made by Sandy Jacobus, the motion was seconded by John Smayda and it was passed unanimously by the board.

### **COMMITTEE REPORTS:**

#### Rescue:

- Lady Update: 10 year old was officially placed by Marisa Fowler. The owner was moving
  to New York and had cancelled several times due to the difficulty of parting with the dog.
  The dog was spayed and adopted out. It was asked that donations be made by the party
  relinquishing the dog and the family adopting Lady to partially pay for the blood work and
  spay.
- Lucy Update: It was learned that Lucy was recently put down due to the escalating
  aggression issues. (Lucy was not officially in the CVVC program but Marisa was assisting
  the foster family).
- Sophie: The six year old was placed this month. The family had been unable to pay for
  veterinary care and the dog hadn't been seen since 2008 for vaccinations or examinations.
  When the owner was diagnosed with cancer it was decided it was best to relinquish the
  dog. Marisa placed Sophie when she ran into someone she had done a home inspection
  for a potential rescue last fall and they agreed to take Sophie.

## **Old Business:**

- CT Dog Federation: Susan Potocik agreed to be the club's delegate for the Connecticut Dog Federation. The application has been filled out and is ready for submission.
- PayPal: John Smayda volunteered to be the lead on the PayPal Account. We are going to
  use samples that are simple entries to use as a test transaction to run through the account.
  We hope to use PayPal for normal club transactions such as: annual dues, entries,
  merchandise and donations. We are currently set up with a password for the PayPal
  account but have not yet accessed the account or run a test transaction through the
  system.
- Tax Status: Linda Morris and John Smayda have planned a meeting with the attorney to discuss the club's tax status situation tomorrow (4/22). The attorney sent a list to the club for review of documentation that may be required.
- Bylaws: AKC came back with some recommendations on Section 2: Dues. The club currently has different membership tiers/at different membership due amounts and the bylaws will be re-worded to a blanket statement that dues will not exceed \$50.00 for any membership level. By re-wording to a more generalized statement the bylaws will not need to be changed each time there is a change in membership dues for any of the membership tiers. AKC suggested that the Chair/Committee positions for the Standing Committees be combined as one position. There were some other small changes with wording that were changed with AKC's recommendation.
- Rescue: Some procedures and guidelines need to be written up for the Rescue committee so that a protocol set up by the club can be followed.

#### **New Business:**

- Field Dates: Linda Morris will be contacting Rich Murphy to see if there is any chance CVVC's HT dates for next year will be close to our dates in the past.
- 2014 Slate: Any nominations will be taken from the floor at our May 19, 2014 and the new board will be voted in by the membership at the June specialty.
